## OPA A YEAR IN REVIEW

The OPA has been extremely busy over the last year. I completed a review of issues we are following and trying to influence and see certain issues never seem to die. The Liberal government continues to move issues forward but the rate on some issues is extremely slow. Some of the issues we have been following include:

### 1. ACCESS ISSUES:

The need for access for explorers is the most critical of all issues these include access to capital, lands, geoscience data and labour.

**Capital:** The Federal government had set a sunset date on the "super" flow through tax program at the end of 2005. This meant that most companies and funds scrambled to take advantage of the last year. In a question I put to a financial house on where we are going this is the response I received "The 15% "super flow through "Federal Investment Tax Credit has not been renewed yet, however there is a proposal before the government in Ottawa to do so which did not happen before the election was called. It may be renewed after the new government takes office.

The 100% CEE deduction for Flow through is still available as well as the 5% provincial credit for funds spent in Ontario. Many of the flow through funds are getting ready to raise capital based on these figures".

The PDAC and OPA actively lobbied to get

an extension to the "super" portion of the flow through. Most provinces kept their top off portion and also lobbied for an extension. The PDAC was active in trying to get the "super" portion as a constant that would not have a sunset.

I spoke with some people who believed the Province should increase the provincial credit to a level that would increase the funds staying in Ontario. Obviously, funds from Ontario that are invested in Juniors would then be directed to Ontario projects?!

**Lands:** The Ontario Living Legacy Disentanglement continues to move forward. Yes it is slow, but it is happening. Additional Room to Grow exercises are few and far between which means we are not as active as other years on direct Parks consultation.

Changes to the Parks Act are presently in the Legislature. The OPA is part of a Resources Mangers committee that includes most of the associations that actively use the Crown Land base for economic or recreational use. This group is addressing the parts of the changes to the Parks Act that may effect each of us. The OPA's biggest concern with the proposed changes actually comes from the initial press release announcing the changes. Within the press release there was a statement that we interpret as the development of buffer zones around protected areas that would be directed by policy not legislation. This is troubling because "policy" especially within MNR can be

interpreted differently by different Regional Managers. Also to work across the province we need transparent, consistent rules.

Recently there has been another flurry of First Nation community moratoriums stating the desire not to have exploration or development on their traditional lands. The OPA awaits the Federal and Provincial governments solutions to these conflicts.

Bill 97: An Act Respecting the Sharing of Resource Revenue with First Nations. This Bill is still within the Legislature and the industries that wish to and already operate on traditional lands await the Legislatures decision.

Northern Boreal Initiative (NBI): NBI is another issue that will effect access north of the present line of forestry activity. Various dates for this MNR driven process, have come and gone. The OPA continues to be at the table as this process proceeds and will inform members when events occur.

The OPA continues to work on the Minister's Mining Act Advisory Committee. The committee had a busy year proposing various changes to the Mining Act that would assist in diffusing conflict between Surface Rights and Mining Rights holders specifically in Southern Ontario. Portions of these recommendations to the Minister, are incorporated in the governments Mineral Development Strategy.

**Geoscience Data:** Over the past year significant contributions to, and plans to enhance the provincial geoscience database have occurred. The Discover Abitibi and Lake Nipigon Region Geoscience Initiatives both produced significant data. These data sets lead to increase staking and exploration in both areas and will assist explorers for years to come.

The other significant geoscience announcement was the MNDM's Far North Initiative. This program of \$5.0 per year over 3 years was announced amid a Provincial Budget of cuts. Congratulations must go to our Minister and his behind the scenes staff for prying cash from a fiscal process that usually doesn't see past Parry Sound. This funding will allow the explorers of the Far North to target exploration and enhance the northern economy.

Other projects the OPA have been involved in include the Geoportal project. This project is an internet based system that will allow users to

access land, claims, geoscience and assessment databases in a more seamless and friendly method. The OPA is extremely excited about this project as it will move Ontario back to the forefront of information transfer. Watch for this new system to be launched soon!

**Labour:** There has been various studies on the industries employment replacement needs over the next few years. In a recent presentation to the Ontario Mineral Industry Cluster Council (OMICC) (OPA holds a seat on the council) numbers like 80,000 skilled labourers in 10 years will be required across the industry. Geologists alone are in extreme demand, the OPA gets weekly calls looking for trained geologists. OMICC and the Ontario Mining Association are committed to making these needs public and hopefully proactively solving the needs. The OMA recently completed a publication for High School students called Rock On. The magazine formatted document highlighted employment opportunities within the industry. The high tech nature and potential salary structure is documented very well. The magazine is located on the OMA website.

## 2. MINERAL DEVELOPMENT STRATEGY

Mineral Explorers of the province have been pushing for a Mineral Policy for over 10 years. Once in a meeting a previous Minister related a story about seeking experts on ground water and geology. He stated his government ended up talking with a consulting group in Texas. Later when he became Minister of NDM he realized the experts he needed were already on staff in Sudbury. The need for a Mineral Policy goes further than a method of informing government on what MNDM does it also defines the industry and lays a format on how our interests are treated and respected in multi ministry decisions. The OPA provided comments to the proposed Strategy and looks forward to working with the Ministry on delivering the final product.

### **3. NORTHERN DEVELOPMENT POLICY COMMITTEE FOR THE PC PARTY**

The OPA was invited to submit issues that effect explorers of the province to the opposition. This document listed our present concerns and recommended the direction we thought would assist us best in the future.

### **4. PROFESSIONAL LIABILITY INSURANCE AND WORKERS SAFETY AND INSURANCE REQUIREMENTS**

The OPA was contracted, in the fall, by PDAC, to prepare a document that review the requirements and rates of both Professional Liability Insurance and Workers Safety and Insurance. This survey reviewed the various rates and requirements across the provinces and internationally. The survey was presented to the PDAC Board in December. Once accepted by the Board OPA will ask that we can publish the results on our website for our members to review.

### **ONTARIO EXPLORATION AND GEOSCIENCE SYMPOSIUM Toronto, December 2005**

Accepting the award was John Halet President of NWOPA.

The Minister of Northern Development and Mines Rick Bartolucci addressed the attendees at the opening ceremonies and toured the more than 40 booths and 40 posters. The 50 speakers presented informative and current talks on new geophysical developments, exploration results

**The Auditor General has delivered his 2005 report.** Please see [http://www.auditor.on.ca/en/reports\\_en/en05/309en05.pdf](http://www.auditor.on.ca/en/reports_en/en05/309en05.pdf) for a complete copy of the comments on the Ministry of Northern Development and Mines. Below please see the part of the summary of the Auditor's comments on the MNDM that effects us.

#### **SUMMARY**

—Due largely to the quality of the maps and advisory assistance it provides, the Ministry is generally seen by its stakeholders as contributing to the success of the mining industry in Ontario. However, the Ministry did not have adequate procedures in place to ensure compliance with legislation and its internal policies or to measure and report on its effectiveness. There are a number of operational areas that the Ministry can focus on to improve its delivery of the Mines and Minerals Program:

—To maintain a mining claim in good standing, the holder must perform certain exploration work, referred to as assessment work, and must report this to the Ministry. We found that the

Ministry reviews most assessment reports for reasonableness, but this process was not sufficient to ensure that only allowable exploration expenditures were approved. As well, the Ministry had performed a detailed expenditure verification on only 31 of 5,200 reports submitted since 1999, and had carried out only one inspection of a claim site to verify that the work had actually been done. Such verification is necessary, as we noted cases where claim-holder had falsified assessment and expenditure information.

—Geological information provided by the Ministry is used by prospectors and mining companies to select areas in which to conduct exploration work. Based on input from its clients, the Ministry determined that a mapping productivity benchmark of 20 years, or about 15,000 square kilometres a year, was a target for areas of high mineral potential to keep geological information current and relevant. However, due to difficulties in completing projects on a timely basis and to resourcing and capacity issues, from 2002 to 2008 the Ministry had mapped or planned to map only 8,000 square kilometres annually. For example, of the 46 Precambrian projects that were to be completed by December 2004, 10 were still ongoing and 15 were completed late. In addition, the Ministry did not have a project management system to periodically report on the status of active projects.

—At the time of our audit, the Ministry had identified more than 5,600 abandoned mine sites dating from the early 1900's. The Ministry had estimated that 4,000 of these sites were potentially hazardous to public health and safety and that approximately 250 of these sites might pose an environmental risk due to the potential for the leaching of minerals and other contaminants from mine tailings. However, the Ministry did not have adequate information on the chemical contamination that is often the by-product of mining operations. This information is necessary to assess the risk of water and soil contamination around abandoned sites.

The Ministries Response are included in the Auditor's Report.

### **Institute on Lake Superior Geology**

The 52<sup>nd</sup> Annual Meeting of the Institute on Lake Superior Geology will be held in Sault Ste Marie, Ontario from May 8 to 12, 2006. Co-chairs for this meeting and field trip leaders include several geologists from the Ontario Geological Survey (OGS) as well as two recently retired OGS geologists.

Right on the international border Sault Ste Marie, Ontario is easily accessible for registrants from both Canada and the United States. The city is an ideal location from which to base day-long field trips investigating topics as diverse as the stratigraphy of the Paleoproterozoic Huronian Supergroup in the Elliot Lake area, the bedrock shoreline features of Mackinac Island and Archean diamond occurrences in the Wawa area. A technical session highlighting diamond exploration in the Lake Superior basin is planned. The ILSG returns to Sault Ste Marie for the first time since 1974. Two of the proposed field trips reprise excursions featured then. Although the rocks may not have changed, the ideas about them certainly have and we anticipate plenty of inspired geological discussions.
